- David introduced Gary Groshon to share about the need and steps we might take to replace the larger playground equipment.
- Gary shared that the playground has multiple safety concerns with rusted parts, cracked plastics and has been in service beyond its anticipated life expectancy. The ground cover of pea gravel is of concern as well. There are options to be explored.
- David then shared that this would need to be something the church looks into replacing as there are some funds available but suggests we complete the office rebuilding project first.

- If all goes how we hope it will, the Search Team will make its recommendation to the Personnel Committee very soon who will then be able to make an offer of employment which the church will have a vote of affirmation of the team's and committee's work.
